*** Harassment is defined as any unwelcome, hostile and offensive verbal written or physical conduct based or directed at a person's protected class that (1) results in physical, emotional or mental harm or damage to property; (2) is sufficiently severe, persistent, that it interferes with an individual's ability to participate or in or benefit from an educational program or activity; or (3) substantially disrupts the orderly operation of the school. (Note: Sexual harassment is addressed in the last section, below.)*
