INTRODUCTION

The Department Lead Teacher, Building Principal, Dean of Secondary Educational Philosophy, and Director of Academic Services will review and approve all new course proposals prior to acceptance by the TCA Board of Directors. Teachers must submit proposals for new courses at least eight (8) months prior to (on or about December) new course implementation.

PHASE 1: Department Lead Teachers (DLTs) will distribute the phase one course approval form (IIAC-TCA-E-6) to all members of their department within the first week of October. Teachers must submit the completed form to their DLT no later than the first Monday in November in order to be eligible for consideration the following year. DLTs will provide the DSEP with all forms by COB on the first Monday in November. Upon review and acceptance of the initial proposal by the DLT and DSEP, the requesting teacher will then proceed to Phase 2 in order to provide more detail for the proposed course.

PHASE 2: Requesting teachers will complete and submit to their DLT the Phase 2 new course proposal form (IIAC-TCA-E-6) no later than the second Friday in November. If the PHASE 2 proposal is accepted by the DLT, principal, DSEP, and DAS, it will be submitted to the TCA Board of Directors at the December Board meeting.

This TCA policy replaces ASD20 Policy IIAC-E-3.
