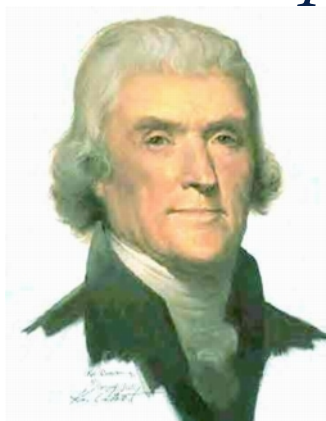

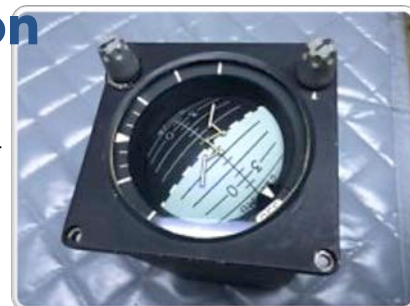

# The ATTITUDE Indicator – A Life Lesson

I spent 15 years of my Air Force career flying helicopters like the one shown in the picture below. Instrument flying was always a challenge in these Vietnam-era helicopters since there was no flight stabilization or auto-pilot type systems on board. When conducting instrument flight the most important gauge is the one pictured to the right, the attitude indicator. The flight manual for the UH-1N states (I keep a copy in my office for reminiscing) - **WARNING:** Do not attempt instrument flight without two operative attitude indicators. It also notes that prior to takeoff, *adjust the attitude indicators* by aligning the pitch and roll adjustment knob reference marks with the zero trim dots (you can see the adjustment knobs on the top of the indicator above and on the right side of the picture in the bottom right). *Failure to properly adjust the attitude indicator at the ground checkpoint prior to takeoff* would lead to devastating results once airborne and in the clouds. In instrument flying a fundamental skill is "cross-checking" the instrumentation. Utilizing a *continuous and logical cross-check sequence* of the attitude indicator and performance instruments is critical to stabilized flight (see images below). As indicated in the cross check diagram, when using the radial cross check method a pilot's eyes spend 80-90% of his/her time looking at the attitude indicator, adjusting one's vision for quick glances at the surrounding performance instruments – but *always cross referencing with the attitude indicator* [for more information copy and paste- [http://www.hatcheraviation.com/uploads:IFH\\_FAA-H-8083-15A\\_6.pdf](http://www.hatcheraviation.com/uploads:IFH_FAA-H-8083-15A_6.pdf)]. "Fixation" on any one instrument – whether the attitude indicator or surrounding performance instruments can also lead to catastrophic consequences – a pilot must constantly and properly utilize the surrounding instruments to ensure stable and coordinated flight. Over the years, I have thought many times about the attitude indicator and proper instrument flight. For me – when I went into the clouds a properly adjusted and monitored attitude indicator, with a strong and methodical cross check, was a "life or death" proposition.

## Personal Attitude Application

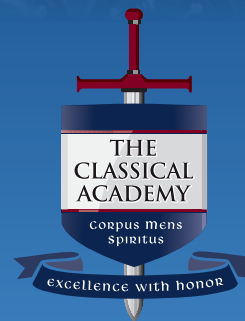
1. Always make sure my attitude is checked prior to starting the day

## TCA Board Approved Common Core Resolution



### The Classical Academy

#### Resolution Concerning Common Core and Assessments

Adopted by the TCA Board of Directors on January 13, 2014.

**WHEREAS**, the Colorado Charter Schools Act states “that the best education decisions are made by those who know the students best and who are responsible for implementing the decisions” and encourages “diverse approaches to learning and education and the use of different, proven, or innovative teaching methods;”

**WHEREAS**, the Colorado Charter Schools Act provides “parents and pupils with expanded choices in the types of education opportunities that are available in the public school system;”

**WHEREAS**, the Colorado state constitution mandates that Colorado is a local control state, wherein local school boards, including those governing charter schools, are constitutionally provided discretion in setting curriculum for their students and, according to the Colorado Charter Schools Act, allowed to develop “different and innovative forms of measuring pupil learning and achievement;”

**WHEREAS**, The Classical Academy is accountable by law and charter for meeting Colorado State Board of Education content standards and assessment criteria, and has consistently exceeded all such standards since its inception in 1997;

**WHEREAS**, The Classical Academy is rated one of the top schools in the state of Colorado by national and state organizations and has the second lowest college student remediation rate among Colorado high schools as documented in the Colorado Department of Higher Education 2012 Legislative Report on Remedial Education;

**WHEREAS**, The Classical Academy has successfully pursued and proven the value of rigorous academic standards in a classical approach to education that combines academic and character education in pursuit of what is true, beautiful, and good;

**WHEREAS**, The Classical Academy has found the exceedingly expensive, unfunded technological requirements necessary to administer the new testing a major burden for a charter school and a significant departure from our core values, curricular and pedagogical choices, and what we consider developmentally appropriate for early grade levels, with regard to technology use in the classroom;

**WHEREAS**, The Classical Academy has found the exceedingly intrusive testing regimen and its drastic impact on student instructional contact time to be detrimental to the ideals of a classical education;

**WHEREAS**, the Common Core State Standards, and associated testing methodology, while potentially reasonable for some schools to emulate, are not reasonable or philosophically

appropriate at The Classical Academy because our academic standards are more rigorous, more thorough, and more directly tailored to our students' individual needs, as they prepare to become exemplary citizens of the community, state, and nation.

**THEREFORE BE IT RESOLVED**, that The Classical Academy Board hereby expresses its opposition to the imposition of the Common Core Standards Initiative and the mandate by the State Board of Education and the Legislative Bodies in the State of Colorado to impose the required assessments into the academic schedule. Specifically, the major areas of concern for The Classical Academy are;

- the one-size-fits-all implementation methodology,
- the intrusive and costly technological element of the testing,
- the pedagogical concerns of the testing methodology, specifically computerized testing for elementary grades, versus traditional pencil and paper assessments, and
- the impact on the autonomy of charter schools in determining curriculum choices.

Ultimately content standards at a national level will drive conformity, instead of innovation, and mediocrity instead of excellence. The Classical Academy remains committed to its founding principles and core values and while committed to following state requirements, we call upon the Governor of the State of Colorado, the State Board of Education, the Colorado General Assembly, and the Colorado Department of Education to reconsider their actions in view of the stated concerns of The Classical Academy and numerous other charter schools, authorized by the Colorado Charter Schools Act to "create a legitimate avenue for parents, teachers, and community members to take responsible risks and create new, innovative, and more flexible ways of educating all children within the public school system."

## TCA Evacuation Drill Update

exercise ASD20 and TCA roles and responsibilities, and build a team that is confident in handling a crisis - ensuring the safety of all students and staff. All campuses (except the Cottage School Program) participated. Administrators at the Cottage School Program followed up with a walk-through and procedures discussion on January 7. The exercise proved extremely valuable and provided much feedback for TCA and ASD20 to incorporate into our planning processes. TCA would like to thank all the staff who participated with an outstanding attitude, the ADS20 security staff, and New Life Church. The response to the effort from all involved was overwhelmingly positive and a major step forward in our safety and security process.

**Dr. Russ Sojourner** currently serves as the Director of Leadership Development at Character Education Partnership based out of Washington, DC. Dr. Sojourner has a BS in Behavioral Science, a MS in Industrial Engineering, and a PhD in Psychology. After graduating from the United States Air Force Academy, Dr. Sojourner served in the Air Force for 20 years, including tours at the Air Force Academy as an Instructor, Assistant Professor, and Associate Professor in the Department of Behavioral Science and Leadership. Dr. Sojourner also served in the Air Force Academy's Center for Character Development, in charge of character and leadership development for the 4,400 member cadet wing. Upon retiring from the Air Force in 2004, Dr. Sojourner became an Assistant Principal and Director of Character Education and Development at The Classical Academy. Dr. Sojourner spent his last seven years at TCA as the Junior High Principal.

**Dr. Bruce Speck** most recently served as the President of Missouri Southern State University in Joplin, MO from 2008-2013. Dr. Speck holds a BA in English from the University of Northern Colorado, a MAE in English from Wayne State College in Nebraska, and a PhD in English from the University of Nebraska-Lincoln.
